## What is Deferred Action?

The Deferred Action for Childhood Arrivals (DACA) is a program that will provide a renewable 2-year work permit and temporary protection from deportation to those who were under the age of 31 on June 15, 2012 and entered the United States before the age of 16. **If you have a Previous Deportation Order, You May Still Qualify**

**TO APPLY YOU MUST PROVE ALL OF THE FOLLOWING REQUIREMENTS (*Please read carefully*):**

**1. Must be 15yrs or older in order to apply**

**2. Must have been younger than 31yrs old on 06/15/2012**

- You need your Birth Certificate **AND one of the following:**
- Valid Passport or Consular ID *–school ID is not valid for these purposes*

**3. Must have entered the country BEFORE the age of 16**

- School Transcripts -request your record at: [http://cps.edu/About\\_CPS/Departments/Pages StudentRecords.aspx](http://cps.edu/About_CPS/Departments/Pages StudentRecords.aspx)
- If you did NOT register for school, you must still prove this requirement with other documentation

**4. Must have lived in the US since 06/15/2007 AND must have been in the US on 06/15/2012**

**\*\*ONE (1) document per month** since June 15, 2007 until the present. **ALL documents must be organized by date; they must be under your name.** You may bring documents such as: Utility Bills; Bank Statements; Medical Records; Medical card; Income Taxes; Check Stubs; School Transcripts; Cumulative Progress Report

**5. Must be currently enrolled in school OR must have graduated from High School, obtained equivalence, GED or have been honorably discharged from the Military Service or U.S. Coast Guard**

- School Transcripts **AND** H.S. Diploma or GED Certificate **OR** proof of enrollment

**6. Have NOT been convicted of a felony, significant misdemeanor or 3 misdemeanors**

- To determine your eligibility bring the FINAL DISPOSITION of each arrest on the date of your appointment

*Note: If you have NEVER been arrested you do NOT need to bring a criminal record*

**7. List of all the addresses where you have lived since you came to United States along with the dates at each address**

**8. Cost to Apply -Money orders**

\$410.00— Payable to USCIS for work permit

\$85.00—Payable to USCIS for biometrics (fingerprints)

\$200.00— Payable to Centro Romero (DACA)

\$30.00— Payable to Centro Romero (Consultation)

**STOP BY WITHOUT AN APPOINTMENT ON SATURDAYS FROM 9:00AM TO 12:00 PM EXCEPT FOR THE FOLLOWING DATES:** 04/15/2017; 11/25/2017; 12/16/2017; 12/23/2017; 12/30/2017
